

Lifeguard Certification Course will teach you the skills necessary to be a certified American Red Cross Lifeguard. This **four-day** course includes Red Cross training in both **shallow and deep water** life-guarding, First Aid, CPR, and AED (Automated External Defibrillator). You will be a certified ARC lifeguard and ready for employment for any aquatic facility (including Calphin) when you successfully finish the program and pass the required tests. **Qualifications:** Must be 15 years of age by the last day of class. Must be able to do the following three prerequisites on the first day: **Prerequisites Part 1:** 300 yd swim (front crawl/ breaststroke/ or combination of both). **Prerequisite Part 2:** Tread water for 2 minutes without arms. **Prerequisite Part 3:** Swim 20yd using front crawl or breaststroke, surface dive & retrieve a 10lb brick from 7-10 ft water, return 20 yd to side of pool, and exit pool – time requirement: 1 minute 40 seconds *(Pool Admission Ticket can be purchased for prerequisite self-assessment, upon registration.)* *Register by December 4, 2015.*

- The registration minimum to open a class is 6 students. Please be aware that your requested class may be cancelled if enrollment is below the minimum and in that case a refund will be issued to you.
- No refunds on or after the first day of the course, unless prerequisites aren't met and a \$30 processing fee will be charged.
- If you miss any classes, you will not pass the course - No make-up classes will be offered – **Attendance is Mandatory.**
- If class is cancelled due to pool maintenance/accidents, mandatory make up class will be scheduled for the group.
- Bounced check subjected to \$25 charge. Lifeguard, First Aid, AED, and CPR certifications are all valid for 2 years.
